# **Annual Bayz Bonanza - Terms and Conditions**

#### 1. Introduction

The Annual Bayz Bonanza (the "Competition") is run by the Doubtless Bay Business Association (the "Promoter"). Participation in the Competition is deemed acceptance of these Terms and Conditions.

# 2. Eligibility

- 2.1 The Competition is open to all New Zealand residents aged 18 years or over.
- 2.2 Trade accounts and commercial purchases are not eligible for entry. Only personal, retail purchases made by individuals for their own use will be accepted.

# 3. Entry Requirements

To enter the Competition, participants must complete all the following steps between 12:00 AM on August 1st, 2025, and 11:59 PM on August 31st, 2025 (the "Competition Period"):

- a. Spend a minimum of \$50 NZD at any business located in Doubtless Bay during the Competition Period.
- b. Post about their purchase on Facebook, including #BayzBonanza in the post.
- c. Like and follow the Doubtless Bay Business Association Facebook page.
- d. Email proof of purchase (e.g., receipt or invoice) to chair@doubtlessbay.co.nz, including their full name and contact information.

Only entries that meet all the criteria above will be considered valid.

## 4. Entry Limit

There is no limit to the number of entries per person, but each entry must:

- -Be accompanied by a separate \$50+ purchase.
- Include a new Facebook post with the required hashtag.
- Have separate proof of purchase submitted via email.

#### 5. Prize and Draw

- 5.1 The winner will be randomly drawn from all eligible entries at 3:00 PM on September 1st, 2025.
- 5.2 The prize will be announced by the Promoter on the Doubtless Bay Business Association's Facebook page. The winner will also be contacted directly using the details provided via email.
- 5.3 The winner must respond within 5 business days of being notified. If the winner cannot be contacted or does not claim the prize in time, a new winner may be drawn at the Promoter's discretion.

#### 6. Prize Details

The specific prize or prize bundle will be advertised separately on the official Doubtless Bay Business Association Facebook page and related promotional materials. Prizes are not transferable or redeemable in cash.

### 7. Verification

- 7.1 The Promoter reserves the right to verify the validity of entries and disqualify any entrant who does not comply with these Terms and Conditions.
- 7.2 Any fraudulent activity, including falsified proof of purchase or fake social media posts, will result in disqualification.

- 8.1 By entering the Competition, entrants agree to the Promoter collecting and using their personal information for the purposes of administering the Competition.
- 8.2 The winner agrees to participate in reasonable publicity, including social media announcements and photographs.

- 9.2 By participating, entrants release Facebook from any responsibility related to the Competition.

- 10.2 The Promoter accepts no responsibility for lost, delayed, misdirected, or incomplete entries.
