Stallholder Information and Terms/Conditions (Keep this page)

- 1. All stallholders need to provide their own set up requirements. Limited number of stall sites available. No specific power sites.
- Stall site charge rates:

Early Bird (prior to 30 Nov 2025) \rightarrow 3mx3m site \$80 6mx3m site \$120 Standard (1 Dec 2025– 13 Feb 2026) \rightarrow 3mx3m site \$95 6mx3m site \$150

Extra charge for vehicle unless integral part of stall - \$50.00 per site (prearranged only - see form below)

3. Application Form and payment for Early Bird registrations must be received no later than 30th November 2025 and Standard registrations and payment close Friday 13th February 2026 (unless all sites presold). Late applications may not be accepted.

PAYMENT OPTIONS:

Application Form send to <u>Secretary@doubtlessbay.co.nz</u>. Invoices will be emailed out once registration has been accepted and processed, Invoices will have a 7-day payment term. Credit card or Internet Banking are accepted.

- 4. If event is cancelled due to weather a refund of 50% of stall site charge is available. If event is cancelled due to government regulation requirements a full refund minus \$10 administration fee is available.

- 5. This event is primarily a celebration of Far North wine, food, and art. While all applications will be welcomed and considered, acceptance is at the sole discretion of Doubtless Bay Business Association Inc. (DBBA)

STALLHOLDER TERMS AND CONDITIONS

- 1. Stall sites will be allocated along Waterfront Drive, Mangonui between Tasman St and the Mangonui Wharf. Doubtless Bay Business Association Inc reserves all rights in respect of location of stalls.
- 2. Stall set up will be from 9.00am on the day (Saturday 28th March 2026). Sites are within zones and each zone has an allocated set up time. Stallholders <u>MUST</u> arrive and be set up by start time of 12noon. This includes removing vehicles.
 - Stallholders that arrive late will not be able to access venue for stall set up.
- All stall sites are situated on the sealed road. Gazebos will need securing using weight bags.
- 4. All stallholders agree to adhere to the District Council bylaws referring to any special license obtained by the DBBA committee (copy will be enclosed in stallholder pack).
- 5. Food vendors need to be registered unless selling food as a fundraiser and comply with all food safety regulations as administered by the Far North District Council.
- 6. The Mangonui Waterfront Festival supports zero waste. All food sold <u>must</u> be in compostable or recyclable containers and no plastic bags will be permitted for "giveaways" or customer purchases.
- 7. Sites will be allocated once signed Application Form & Payment is received and after applications have closed.
 - Stallholders will receive 2 staff wristbands once entered through the check-in station at the main entry points on the day. A site map will be sent out as part of the stallholder pack prior to the event.
 - Stallholders who are not on the registration list and do not hold a site number will be asked to leave the event site.
- 8. Stallholders **must** only use the site/s assigned to them
- 9. Only one vehicle per stall will be permitted on the stall site for **unloading and setting up**. After set-up, the vehicle **must** then be moved to the vehicle parking area by 11.30am. Exceptions may be made in the case of a dedicated vehicle e.g. refrigerated trailer or otherwise by agreement with DBBA. **This will need to be arranged in advance.**
 - No exceptions will be made on the day. DBBA reserves the right to have unauthorized vehicles towed away.
- 10. Only items listed on the Application Form may be sold.
- 11. No open flame appliances are permitted. Gas cooking/generators only.
- 12. DBBA asks that stallholders do not clear their stall site until the end of the event, and the road has reopened (beginning 6pm).
- 13. DBBA accepts no responsibility for any theft, loss or damage to property.
- 14. Stallholders accept responsibility to ensure the health and safety of their staff, visitors and others related to the setup, pack down and running of their site while at the 2026 Mangonui Waterfront Festival and will comply with all relevant health and safety legislation including without limitation the Health and Safety Work Act 2015.
- 15. Stallholders are responsible for their own public liability insurance as it relates to their designated stall site.
- 16. Stallholders indemnify Doubtless Bay Business Association Inc for any losses caused by the actions of the stallholder.
- 17. Doubtless Bay Business Association Inc reserves the right to cancel the festival in the event of adverse weather conditions or Government regulation requirements.
